

ORDER

Provisional recognition is hereby granted to Northridge International School, Sector-46, Chandigarh upto Middle level for the period of four years w.e.f. 1.04.2021 to 31.03.2025 under Article 235 read with 241-A of Punjab Education Code as well as RTE Act, 2009 as well as RTE Act, 2009 subject to fulfilment of the following conditions and other guidelines issued from time to time:-

1. The school will comply with the RTE Act provisions and instructions issued by the Education Department from time to time.
2. Revised Managing Committee should be got approved from the Education Department.
3. Reserve Fund should be pledged in the name of DEO equal to two month's salary of the staff.
4. Provisions of RTE Act and other instructions issued by the Education Department related to admission of students under EWS category and disadvantaged groups be followed in letter and spirit (wherever applicable).
5. Library books should be maintained in the ratio of 1:5.
6. School will follow land allotment conditions and other notifications/ orders/instructions issued by the Chandigarh Administration from time to time.
7. Special educator should be appointed immediately.
8. Salary of the staff should be at par with the teachers working in Govt. School in UT, Chandigarh.
9. Teachers recruited after August 2010 should be TET/CTET qualified.
10. No particular book shop be prescribed for purchase of book/uniform etc by the school.
11. Fire Safety Norms be followed meticulously and there should be no laxity in this regard on the part of the school.
12. Fee should be charged from the students as per CBSE Affiliation Bye Laws and receipt be issued to the students against the money charged from them.
13. Recognition is liable to be withdrawn if the management or the staff of the school take part in agitation against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political or communal agitation;
14. Government reserves to itself the right, to grant, refuse or withdraw recognition at its entire discretion.
15. School will recruit teachers as per NCTE notification dated 12.11.2014 regarding minimum qualification or teachers including the qualifications prescribed for teachers including the qualifications prescribed for teachers at pre primary level as per letter dated 2.04.2018.

The recognition is also subject to the following conditions:-

1. The management will not add any more class/section to the school without the permission of the department.
2. The school will send a quarterly report regarding the progress made towards the fulfilment of various conditions mentioned above.
3. The school will not be transferred to different building or locality, not already approved by the Department.
4. The school will not be transferred to a different Managing Body already approved by the Department.
5. In case the conditions imposed are not fulfilled or the Institution commits some irregularities during the course of the year, the recognition can be withdrawn at any time.
6. Deduction of EPF/CPF should be made as per provisions.
